Indo Spanish Chamber of Commerce is the only business aggrupation of Spanish companies in India. It was created in 2016 and was officially inaugurated by means of an ad-hoc event at the residence of the Spanish Ambassador in India, José Ramón Barañano, in March 2018.

Mission

The Indo-Spanish Chamber of Commerce is a private, non-profit organization where Spanish and Indian business firms exchange knowledge and experience on how best to confront the challenges of operating in India, and for Indian companies, in Spain. Working together, the Chamber helps its members to connect their business with other businesses and with opportunities. Endorsed by the Spanish Government and by the Economic and Commercial Office of the Spanish Embassy in India, as part of the objectives and priorities of the “Internationalisation Strategy of the Spanish Economy, 2017-2027” initiative, the Chamber enhances economic ties between Spain and India.

As an important milestone and token of all the above, Indo Spanish Chamber of Commerce has been recognised by the Spanish Government as the official Chamber of Commerce in India in August 2019.

Scope

The Indo-Spanish Chamber of Commerce acts as an official nuclear point, providing linkages between the Indian and Spanish business communities, covering the whole Indian territory wherever there is a need, with members from the different Indian geographies.
